#### **FutureGlobE**

- Combines 1. critical global governance analysis with 2. foresight
- Participative trend- and scenario analysis of future shifts in global governance
- Horizon scanning, trend analysis and scenarios of stagnation & transformation & fragmentation
- Resulting in policy recommendations and a
- Set of games with future-impacts, JRC and WFUNA developed & piloted
- Current Stage:
- Proposal is in the process of evaluation
- Result should become public in early Autumn. In case of a positive decision the project could start towards the end of 2018/early 2019.

## Experiences in perspective of future preparation for proposals

- Co-ordinators role & input is central to be able to present a very good proposal in time (substance competence, existing network in the field, management and administrative competences/support organisation, sufficient time available (several PMs))
- Competences of all partners with respect to the specific topic and sub-topics have to be very good
- Additional partners have to be included: some with special knowledge in the field and some famous ones (highly competitive names!).
- FEN is not an eligible applicant. It won't be a FEN-proposal, but a proposal incl. cooperation with FEN and possibly the Millennium project.
